The position of any point P in this space is uniquely identified by an ordered triple (x, y, z), representing the signed distances from the YZ, ZX, and XY planes, respectively.

Core Theoretical Framework: Distance and Section Formulas

To operate within three-dimensional space, one must master the primary metrics used to define relationships between points. These formulas are the bedrock of more advanced spatial analysis.

The Distance Formula

Derived from the Pythagorean theorem, the distance between two points P(x1, y1, z1) and Q(x2, y2, z2) is given by the formula:

$$d = \sqrt{(x_2 - x_1)^2 + (y_2 - y_1)^2 + (z_2 - z_1)^2}$$

The Section Formula

When a point R divides the line segment joining P(x₁, y₁, z₁) and Q(x₂, y₂, z₂) in a ratio m:n, its coordinates are calculated as follows:

- Internal Division: $R = [(mx_2 + nx_1) / (m + n), (my_2 + ny_1) / (m + n), (mz_2 + nz_1) / (m + n)]$
- External Division: $R = [(mx_2 - nx_1) / (m - n), (my_2 - ny_1) / (m - n), (mz_2 - nz_1) / (m - n)]$

Direction Cosines and Direction Ratios

In 3D geometry, the orientation of a line is defined by the angles it makes with the positive directions of the X, Y, and Z axes. These angles are denoted as α , β , and γ .

Direction Cosines (DC)

The cosines of these angles, $l = \cos \alpha$, $m = \cos \beta$, and $n = \cos \gamma$ are known as **Direction Cosines**. A fundamental property of DCs is:

$$l^2 + m^2 + n^2 = 1$$

Direction Ratios (DR)

Any three numbers a, b, and c that are proportional to the direction cosines are called **Direction Ratios**. While a line has a unique set of DCs, it can have infinitely many sets of DRs. The relationship between them is:

$$l = a / \sqrt{a^2 + b^2 + c^2}; m = b / \sqrt{a^2 + b^2 + c^2}; n = c / \sqrt{a^2 + b^2 + c^2}$$

Technical Analysis of the Plane

A plane in three-dimensional space is a surface such that if any two points on it are joined by a straight line, that line lies entirely on the surface. Mathematically, a first-degree equation in x, y, and z always represents a plane.

Standard Equations of a Plane

There are several ways to represent a plane depending on the available data:

Form	Equation	Variables/Parameters
General Form	$ax + by + cz + d = 0$	(a, b, c) are the direction ratios of the normal.
Normal Form	$lx + my + nz = p$	(l, m, n) are DCs; p is the perpendicular distance from origin.
Intercept Form	$x/a + y/b + z/c = 1$	a, b, c are intercepts on the X, Y, and Z axes.
Three-Point Form	Determinant method	Used when three non-collinear points are known.

Angle Between Two Planes

The angle θ between two planes $a_1x + b_1y + c_1z + d_1 = 0$ and $a_2x + b_2y + c_2z + d_2 = 0$ is defined as the angle between their normals:

$$\cos \theta = \frac{a_1a_2 + b_1b_2 + c_1c_2}{\sqrt{a_1^2 + b_1^2 + c_1^2} \sqrt{a_2^2 + b_2^2 + c_2^2}}$$

- If the planes are perpendicular, $a_1a_2 + b_1b_2 + c_1c_2 = 0$.
- If the planes are parallel, $a_1/a_2 = b_1/b_2 = c_1/c_2$.

The Straight Line in 3D Space

Unlike 2D geometry where a single linear equation represents a line, in 3D, a line is often represented as the intersection of two planes or via parametric equations.

Symmetric Form

The equation of a line passing through (x_1, y_1, z_1) with direction cosines l, m, n is:

$$(x - x_1) / l = (y - y_1) / m = (z - z_1) / n = r$$

Where 'r' represents the distance of any point (x, y, z) on the line from the fixed point (x_1, y_1, z_1) . This form is particularly useful in computer graphics for **ray tracing** algorithms, where the path of light is modeled as a 3D line.

The Sphere: Definition and Properties

As highlighted in various technical textbooks like *Analytical Geometry-Three Dimensions-Equation of a Sphere*, a sphere is the locus of a point that moves such that its distance from a fixed point (center) remains constant (radius).

The General Equation of a Sphere

The general equation is given by:

- Center: $(-u, -v, -w)$
- Radius: $\sqrt{u^2 + v^2 + w^2 - d}$

Tangency and Intersections

A plane touches a sphere if the perpendicular distance from the center of the sphere to the plane is equal to the radius. This principle is vital in **collision detection** systems in software engineering, determining when two 3D objects occupy the same spatial coordinates.

Advanced Concept: Quadrics and Homogeneous Coordinates

Beyond spheres, analytical geometry covers **Quadric Surfaces**, which are the 3D analogues of conic sections (ellipses, parabolas, hyperbolas). These are represented by the general second-degree equation:

$$Ax^2 + By^2 + Cz^2 + 2Fyz + 2Gzx + 2Hxy + 2Ux + 2Vy + 2Wz + D = 0$$

Classification of Quadrics

Surface Type	Standard Equation	Physical Analogy
Ellipsoid	$x^2/a^2 + y^2/b^2 + z^2/c^2 = 1$	A flattened or elongated sphere (e.g., Earth's shape).
Hyperboloid of One Sheet	$x^2/a^2 + y^2/b^2 - z^2/c^2 = 1$	Cooling towers in power plants.
Hyperbolic Paraboloid	$z/c = x^2/a^2 - y^2/b^2$	A saddle shape (structural roofs).

Homogeneous Coordinates are another advanced tool mentioned in rigorous texts.
