4. Check for Extraneous Solutions: This is a critical step. Squaring both sides can sometimes introduce solutions that do not work in the original equation. Substituting 44 back into " $(44 + 5)$ " yields " 49 ", which equals 7, confirming the solution is valid.

Extraneous Solutions and Mathematical Domain

An **extraneous solution** occurs when the algebraic process produces a value that falls outside the domain of the original radical function. Because the principal square root of a number cannot be negative in the set of real numbers, an equation like " $x = -2$ " has no real solution, even though squaring both sides would suggest $x = 4$.

Functional Analysis: Linear Quantities and Sequences
